



## Terms and Conditions for Red Hot Shopping Special – Harbour City

### When can you enjoy the offer

1. The promotional period for the offer is from 16 January to 1 March 2026.

### What is the offer

2. During the promotional period, you can use your **Eligible Credit Card** to make **Eligible Transactions** at the **Participating Mall** to enjoy the following rewards:

Harbour City Estates Limited reserves the right to request you to present your proof of identity, record the first and last 4 digital of your credit card and capture the images of machine-printed receipt(s) from merchant(s) and corresponding electronic payment slip(s)/ transaction record(s) in logged-in mobile payment App for verification, Harbour City Estates Limited may not process the redemption if you refuse to provide the relevant information.

33. **'Eligible Credit Card'** means any Hong Kong Dollar personal primary, combined additional, separate additional credit cards or UnionPay Dual Currency credit cards (applicable to Hong Kong Dollar sub-account only) issued by **HSBC**, unless otherwise specified.
34. **'Eligible Transactions'** are purchases made in Hong Kong Dollars with an Eligible Credit Card (including Apple Pay, Google Pay™, Samsung Pay and QR code payment via HSBC Reward+) at the Participating Mall during the promotional period. WeChat Pay, Alipay and PayMe are not eligible for this promotion. For instalment payment, only the first month's instalment or first deposit payment amount will be accepted, and the remaining balance cannot be used to participate in any other promotional activities.
