"Spending Rewards at Harbour City with UnionPay Card" Terms & Conditions:

- 1. Spending Rewards at Harbour City with UnionPay Card (refers to "Promotion") is valid from 29 April to 31 May 2022 (refers to "Promotion Period").
- 2. The Promotion is applicable to designated UnionPay Diamond Prestige Cards with card number starting with 62 (refers to "UnionPay Card"), except for the RMB cards issued by specific Hong Kong and Macau card issuing institutions and all UnionPay Prepaid Cards.
