

“Spending Rewards at Harbour City with UnionPay Card” Terms & Conditions:

1. Spending Rewards at Harbour City with UnionPay Card (refers to “Promotion”) is valid from 29 April to 31 May 2022 (refers to “Promotion Period”).
2. The Promotion is applicable to designated UnionPay Diamond Prestige Cards with card number starting with 62 (refers to “UnionPay Card”), except for the RMB cards issued by specific Hong Kong and Macau card issuing institutions and all UnionPay Prepaid Cards. The Promotion is not applicable to Harbour City Prepaid Gift Card. The qualified transaction must be settled via UnionPay network including physical UnionPay Card, UnionPay Mobile QuickPass and UnionPay QR Code.
3. Cardholder is entitled to redeem a HK\$500 Harbour City Gift Card (refers to “Gift Card”) and a 1-year Royal Blue membership of Harbour City VIC Club (refers to “Membership”) upon single spending of HK\$40,000 at Fashion or Watches, Jewellery & Accessories merchants listed on “your guide” at Harbour City with designated UnionPay Diamond Prestige Card during the Promotion Period. Cardholder must present valid Hong Kong Identity Card for Membership registration. The Membership will come into effect immediately on the day of redemption. Once the registration of Membership is confirmed, cardholder will be invited to collect the membership card and Gift Card at Harbour City in person. Gift Card can be collected on the day of redemption if the cardholders are current VIC Club Members; however, they are not entitled to the 1-year Royal Blue membership on top. Relevant terms and conditions apply to the VIC Club membership.
4. Each Member is eligible to redeem gift card once during the entire promotion period. Each eligible transaction and same-day transaction from the same outlet can only be used for redemption once. No split transaction is accepted. Sales slips and machine-printed merchant invoices used in other promotions in Harbour City can be reused in this Promotion.
5. A total of 400 Gift Cards are available for redemption during the entire Promotion Period on a first-come-first-served basis while stocks last. Cardholder is suggested to check the redemption status at the redemption counter.
6. Cardholder is required to login the membership website onsite and present the original copies of valid sales slip(s), machine-printed merchant sales invoice(s), together with the UnionPay Card bearing the same card number on sales slip in person at redemption counters within 14 days from transaction date or on or before 31 May 2022 (whichever earlier). Redemption by merchant staff or third party is not accepted. Staff members reserve the right to ask for identity proof for verification purpose. Sales staff of Harbour City tenants are not eligible to participate in the Promotion.
7. For transactions with UnionPay Mobile QuickPass, Cardholder is required to login onsite and present the eligible virtual UnionPay Card on mobile device or watch, original copies of machine-printed merchant sales invoice and valid sales slip. For transactions with UnionPay QR Code, Cardholder is required to login onsite and present the transaction details in app on mobile device, original copies of machine-printed merchant sales invoice and valid sales slip. Screenshots of mobile device or watch are not accepted.
8. Eligible amount is calculated based on the respective set of UnionPay Card card number and will only include the actual spending amount (only include the net payment amount after deduction of discount, privileged coupons or cash coupons). The transaction amount by the primary and supplementary card under the same Cardholder will be calculated separately.
9. Only original copies of machine-printed merchant sales invoices and sales slips are accepted. The original copy of machine-printed merchant sales invoice should state the merchant name, transaction date, transaction amount and sales items clearly. The original copy of sales slip should indicate the UnionPay Card card number, merchant name, transaction date, transaction amount, valid authorization code and signature of Cardholders (if applicable) clearly. If Cardholders cannot present the valid original copies of sales invoices, sales slips and/or UnionPay Card with consistent information including UnionPay Card card number, merchant name, transaction date, transaction amount etc, or the information provided by Cardholders is insufficient, Cardholders will not be able to redeem gifts for whatever reason.
10. Value-adding receipts, transaction for purchasing cash vouchers/gift vouchers/gift cards and mooncakes are not eligible for redemption. Receipts from bank charges, membership fee payment, medical charges, insurance & investment fee payment, telecommunications services,

bill payment service, car parking fee, car wash services, wedding banquets, private and corporate functions at F&B outlets are not eligible. For instalment transactions, only the first month's instalment payment amount will be accepted for this Promotion. Photocopied, handwritten, duplicate and split receipts are not accepted.

11. All original copies of machine-printed merchant sales invoices will be stamped by staff members at the redemption counter after redemption. Cardholders cannot request for refund from merchants with the stamped sales invoices. Balance of the transaction amount that exceeds the minimum spending requirement cannot be used in other promotions.
12. The first 6 and last 4 digits of UnionPay Card card number and information on cardholders' machine-printed merchant sales invoices and sales slips will be collected for internal audit upon redemption. The information collected will be destroyed 2 months after the Promotion.
13. Gifts cannot be cancelled, altered, transferred, refunded, redeemed for cash nor other gifts and no change will be provided under any conditions once they are issued. UnionPay International Company Limited (refers to "UnionPay International") and Harbour City reserve the right to retrieve or cancel the transferred gifts.
14. Cardholder should refer to the Coupon and Gift Card for their terms and conditions. They will not be re-issued in case of loss or damage.
15. In case of fraud or abuse, UnionPay International and Harbour City reserve the right to disqualify the cardholders immediately and retain the right for legal action. For any disqualified redemption/cardholder, UnionPay International and Harbour City reserve the right to retrieve the gifts.
16. UnionPay International Company Limited and Harbour City are neither vendors nor service providers, thus UnionPay International and Harbour City shall not take any responsibility to the products or services provided by the merchants.
17. UnionPay International and Harbour City reserve the right to amend or terminate the offers and terms and conditions at any time without prior notice, and shall not bear any responsibility caused by the amendments or the terminations.
18. In case of disputes, the decision of Harbour City shall be final.
19. UnionPay International and Harbour City reserve the right to amend the terms and conditions in both Chinese and English version. In case of any discrepancy, the Chinese version shall prevail for all purposes.
