# Malloween Spooky Academy



### 條款及細則:

- 1. 「嘩鬼學院」 活動日期為 2025 年 10 月 18、19、25、26、29 及 31 日。
- 2. 必須成功註冊成為 HARBOUR CITYZEN 會員,並追蹤指定海港城官方社交平台帳號以 換領「搗蛋學生手冊」(下稱「手冊」)一份。
- 3. 憑手冊即可挑戰不同「搗蛋任務」。每成功每挑戰一個「搗蛋任務」,即可獲得一個相對應的 的有效印章。

### 4. 「搗蛋任務」:

- 2. Successfully register as a HARBOUR CITYZEN and follow the official social media accounts of Harbour City to receive a "Mischief Student Handbook" (hereinafter referred to as "Handbook") for FREE.
- 3. Present the Handbook to take on various "Mischief Missions". Each completed "Mischief Mission" earns one valid stamp.

## 4. "Mischief Missions":

- a) Customers must present the "Mischief Student Handbook" to the staff when participating.
- b) Each customer is allowed to use only one Handbook at a time, and each Handbook is limited to one participant. Each customer may participate in each 'Mischief Mission' only once.
- c) Customers are required to present the Handbook to collect designated stamps. Photocopies of the Handbook are not accepted.
