

**購物獎賞條款及細則 Terms and Conditions of Shopping Rewards:**

1. 每位顧客憑同日消費單據最多可換領美容獎賞一次；於推廣期內最多可換領美容獎賞及美容現金券 10 次。美容獎賞及美容現金券數量有限，換完即止。顧客可於換領處查詢優惠之派發情況。
