## <u>Terms & Conditions - "Gucci 5-Time Bonus Points and Rewards Redemption"</u> 「Gucci 5 倍會員積分及獎賞換領」推廣活動條款及細則

- Intended VIC Club Members ("Members") shall enjoy 5-time bonus points upon designated electronic spending at Gucci (Shop G124-125A & G220) in Harbour City from 20 October to 30 November 2022 ("Promotion Period") with the minimum spending of HK\$20,000 each transaction. Each Member is entitled to enjoy the 5-time bonus points with no more than HK\$500,000 accumulated spending with Gucci in the entire Promotion Period.
