遊戲卡條款及細則

Game Card Terms and Conditions

1. 遊戲卡 (下稱「卡」)只適用於2026年6月19日至8月9日。逾期作廢。
Game Card (hereinafter referred to as “Card”) is only valid from June 19 to August 9, 2026. It will become invalid when expired.
2. 顧客必須出示卡方可參加遊戲。
Customers are required to present Card to participate in the games.
3. 顧客必須根據各遊戲的指定要求完成挑戰方可獲得遊戲獎品一份及「O」印章，而該印章亦必須由工作人員蓋上卡上。
Customers must complete the challenge according to the designated requirements of each game to receive a game prize and a “O” stamp, which must be stamped on Card by the staff.
4. 顧客收集四個「O」印章及換領特別禮品時，工作人員會在卡上蓋印，不得異議。
When customers collect four “O” stamps and redeem the special gift, the staff will stamp on the Card. No objection will be allowed.
5. 卡上的所有白色圓圈只供大會蓋印，如圓圈上有任何塗污、塗改或印有任何印章，其參加遊戲資格將一律作廢。顧客不可再次使用同一張卡參加遊戲。
The white circles on the Card are for official use only. The eligibility of game participation will be invalid if the circle areas are found defaced, damaged or stamped on Card. Customers cannot use the same Card to participate in the game.
6. 遊戲名額、獎品及特別禮品數量有限，先到先得，額滿即止。
Quotas applied for all games, prizes and special gifts, and are available on a first-come, first-served basis while stock lasts.
7. 卡影印本恕不接受。
Photocopies of Card are not accepted.
